Interest Rate and Interest Charges	
Annual Percentage Rate (APR) For Purchases	VISA Platinum: 3.25% - 9.25% introductory APR for 6 months, based on Your creditworthiness. After that, Your APR will be 7.25% - 17.50% based on Your creditworthiness at the time You established Your Account. This APR will vary with the market based on the Prime Rate.
Annual Percentage Rate (APR) for Balance Transfers	VISA Platinum: 2.99% introductory APR for 12 months (for transfers conducted by July 31, 2019). After that, Your APR will be 7.25% - 17.50% based on Your creditworthiness at the time You established Your Account. This APR will vary with the market based on the Prime Rate.
Annual Percentage Rate (APR) for Cash Advances	VISA Platinum: 6.25% - 12.25% introductory APR for 6 months, based on Your creditworthiness.
