

Security First Credit Union (SFCU) will be awarding five (5) \$1,000 scholarships for the 2021 -2022 academic year. Submissions are reviewed by our Scholarship Committee and are scored based on the completed application, required documentation, and the completed essay. Reference letters are not required, however, are strongly encouraged.

The scholarship application program begins on **November 2, 2020**, and ends **April 30, 2021*** (*Note: this date is subject to change. Should a change occur, a notice will be posted to our website. Refer to page 6 for submission options). Selected scholarship recipients will be notified no later than **May 31, 2021**, by email. By submission of application, Security First Credit Union reserves the right to use selected applicants' names and any likeness thereof for promotional purposes, including, but not limited to, social media, print, and web.

ELIGIBILITY REQUIREMENTS

- The applicant must be an SFCU member with an active account in good standing, as of 12/31/2020. If you currently do not have an account but want to apply for the scholarship, please visit your nearest branch to open an account by 12/31/2020. To open an account with SFCU, you must either live, work, worship, or study in any of the four (4) Rio Grande counties (Cameron, Hidalgo, Starr, and Willacy).
- The applicant must be a graduating high school student.
- The applicant must be accepted into an accredited college, university, or other postsecondary institution for the 2021-2022 academic year.
- An unofficial copy of current high school transcripts.
- Postsecondary acceptance letter(s) on official typed letterhead.
- Completed essay please refer to page 5 for the essay topic and instructions.

OTHER

- Reference letters may be submitted (with your application) from your choice of teachers, counselors, employers, or community leaders. If unable to submit with your application, these can be mailed or emailed. Please refer to page 7 for the contact details.
- All scholarship funds will be made payable directly to the recipients' attending postsecondary institution.
- Open to children of Security First Credit Union employees. The applicant must be a member or become a member by 12/31/20.
- Not open to children of Security First Credit Union board members and senior staff.
- The applicant must submit all required documents with application.
- Incomplete applications will not be eligible.

HOW TO APPLY

ONLINE APPLICATION: This application process must be done entirely in one sitting. There is NO option to save or return to complete the application later. Follow the prompts and ensure all documentation is ready (required essay, reference letters [if submitting], unofficial copy of transcript[s] as stated in, and postsecondary acceptance letter[s]).
