2022 Scholarship Application



Security First Credit Union (SFCU) will be awarding five (5) \$1,000 scholarships for the 2022 -2023 academic year. Submissions are reviewed by our Scholarship Committee and are scored based on the completed application, required documentation, and the completed essay. Reference letters are not required; however, they are strongly encouraged.

The scholarship application program begins on **August 1, 2021** and ends on **January 31, 2022**. Selected scholarship recipients will be notified no later than **March 15, 2022**, by email. By submission of application, Security First Credit Union reserves the right to use selected applicants' names and any likeness thereof for promotional purposes, including, but not limited to, social media, print, and web.

ELIGIBILITY REQUIREMENTS

- The applicant must be an SFCU member with an active account in good standing as of 12/31/2021. If you currently do not have an account but want to apply for the scholarship, please visit your nearest branch to open an account by 12/31/2021. To open an account with SFCU, you must either live, work, worship, or study in any of the four (4) Rio Grande counties (Cameron, Hidalgo, Starr, and Willacy). If the applicant is already a member but has relocated, they are still eligible to apply.
- The applicant must be classified as a graduating high school student.
- The applicant must be accepted into an accredited college, university, or other postsecondary institution for the 2022-2023 academic year.

REQUIRED DOCUMENTATION:

- An unofficial copy of the applicant's current high school transcripts.
- Applicant's postsecondary acceptance letter(s) on official typed letterhead.
- Completed SFCU essay – please refer to page 5 for the essay topic and instructions.
- If selected as a scholarship recipient, an Enrollment Verification Letter from the applicant's attending postsecondary institution will be required.

OTHER:

- Reference letters may be submitted (with your application) from your choice of teachers, counselors, employers, or community leaders. If unable to submit your application, these can be mailed or emailed separately before the application deadline. Reference letters are not required; however, they are strongly encouraged.
- All scholarship funds will be made payable directly to the recipients attending postsecondary institutions.
- Open to children of Security First Credit Union employees. The applicant must be a member or become a member by 12/31/21.
- Not open to children of Security First Credit Union board members and senior staff.
- Incomplete applications will not be eligible.
